AN ACT

To modify the boundary of the Vicksburg National Military Park in the State of Mississippi, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Vicksburg National
3 Military Park Boundary Modification Act”.

4 **SEC. 2. VICKSBURG NATIONAL MILITARY PARK CONVEY-**
5 **ANCE AND BOUNDARY MODIFICATION.**

6 (a) CONVEYANCE.—

7 (1) IN GENERAL.—The Secretary of the Inte-
8 rior (referred to in this Act as the “Secretary”) shall
9 convey to the State of Mississippi (referred to in this
10 Act as the “State”), by quitclaim deed and without
11 consideration, the Federal land described in para-
12 graph (2) to be used in accordance with subsection
13 (c).

14 (2) DESCRIPTION OF FEDERAL LAND.—The
15 Federal land referred to in paragraph (1) is the fol-
16 lowing:

17 (A) The parcel of approximately 1.69 acres
18 of Federal land within the boundary of Vicks-
19 burg National Military Park (referred to in this
20 Act as the “Park”), as depicted on the map en-
21 titled “Vicksburg National Military Park Pro-
22 posed Disposal of a Portion of NPS Tract 01-
23 103”, numbered 306/194,908, and dated Sep-
24 tember 2024.

25 (B) The parcel of approximately 5.74 acres
26 of Federal land within the boundary of the

1 Park, as depicted on the map entitled “Vicks-
2 burg National Military Park Proposed Disposal
3 of a Portion of NPS Tracts Near Union Ave”,
4 numbered 306/194,907, and dated September
5 2024.

6 (b) BOUNDARY MODIFICATION.—On conveyance of
7 the Federal land described in subsection (a), the Secretary
8 shall modify the boundary of the Park to exclude the Fed-
9 eral land conveyed.

10 (c) USE OF LANDS.—The Federal land conveyed to
11 the State under this Act—

12 (1) shall be used to facilitate public access to
13 the Park and to enhance the visitor experience at
14 the Park in a manner consistent with the interpreta-
15 tive mission of the Park, as determined by the Sec-
16 retary;

17 (2) shall not be used in a manner that ad-
18 versely impacts Park resources or the Park visitor
19 experience, as determined by the Secretary; and

1 (3) shall be subject to any use restriction the
2 Secretary determines to be appropriate.
